Jonathan Fernandez State DWI Manager was here from Santa Fe to explain the outcome of the Grant Application. The reason for the low grade received and budget cut. The grant was cut 27% to pay back Tax and Revenue on the overpayment of FY 2007. The reason for low grade on Application was because of the reports being late during the transition of hiring a new Coordinator. Grant funds will be increased next fiscal year if all programs are explained better at the Application and all reports shall be submitted in one format.

DWI Grant approved Allocations for FY 09. Distribution was allotted \$317,352.36 and Grant was allotted \$50,000.00. To continue receiving funds the DWI program will have to hire a DWI Prevention Specialist.

Approval from Stan Riggs was given to contact Eddy County and see if we can contract with their Prevention Specialist.

Report from Project Graduation Adhoc Committee will evaluate the application for next year.
